PROGRESS REPORT OF JASPER OUTDOOR POOL



Trees are planted on the South hill separating St. Thomas Medical Center. Concrete has all been poured, fencing, and entrance gates are installed. The pool is painted and filled with water. Mr. Moorman noted that invitations were sent for a walk through to City Council, Redevelopment Authority, Redevelopment Commission, Board of Public Works and Safety, and the Park Board for May 18, 2025. Grand opening is still planned for Memorial Day weekend, May 24, 2025.
