## STORMWATER DEPARTMENT REPORTS by City Engineer Chad Hurm

Main Street - North Update: City Engineer Chad Hurm stated that currently stormwater sewer is being placed between 8<sup>th</sup> & 9<sup>th</sup> Street. All inlets and storm sewers are completed in Popular Lane.

**Trail Project:** City Engineer Chad Hurm stated that all Stormwater sewers are placed in Northwood Avenue. All inlets and storm sewers are completed in Popular Lane.

**CCMG 2024-2 (Country Club Estates)** City Engineer Chad Hurm stated that all inlets and storm sewers are completed in Popular Lane.

# STORM WATER DEPARTMENT REPORTS by Stormwater Coordinator Chad Mundy

**ERU Update:** Stormwater Coordinator Chad Mundy presented to the Board a copy of the April 2025 Building Permits, with a total of ten ERUs indicated on the list. Secretary Greg Kuntz made a **motion** to approve the lists as presented with ten total ERUs from the building permits. Chairman Roger Messmer seconded the motion. **Motion** Passed 2-0.

**IDEM Monthly Report:** Stormwater Coordinator Chad Mundy stated that the monthly IDEM report has been completed and filed. The report listed 6 open sites that were inspected. There were five rain events over ½" of rain and a total of 7.97" of rain for the month of April.

**Site updates:** Stormwater Coordinator Chad Mundy updated the Board on several construction sites in the city. He noted progress on each site.

**Erosion Control Permits:** Stormwater Coordinator Chad Mundy stated that there was one new permit. The permit for the Archangel Addition Project. There have been no new plans received since last Board meeting.

**Illicit Discharge & Spills:** Stormwater Coordinator Chad Mundy stated there were three illicit discharge and illicit spills to report.

- A Blitz Transport semi hit a concrete post causing power steering fluid to pour out. Absorbent was placed on the spill to soak up and clean up the mess.
- Emergency waterlines were used on the Birk Drive waterline project. Millings were used to help hold the water lines in place. Inlet covers were added to eliminate the risk of millings entering the inlets.
- Wilson Concrete company needed to install a concrete washout. They purchased a kid pool to solve the issue.

**IDEM Update:** Stormwater Coordinator Chad Mundy stated that the Annual Report is now completed and did receive confirmation that the report was adequate.

**Southwestern Indiana Stormwater Partnership:** Stormwater Coordinator Chad Mundy stated that he attended the conference this month.

**Earth Day:** Stormwater Coordinator Chad Mundy stated that the event was on April 22nd at Memorial Hospital and the event was a success.

**Hike & Learn Project:** Stormwater Coordinator Chad Mundy stated that this event will be on June 7, 2025. The free event will host several partners and cover many aspects of water quality and forest health.

**Jasper Middle School Science Classes:** Stormwater Coordinator Chad Mundy stated he will be teaching all 8th grade science classes at the Jasper Middle School on May 15th. He will give a presentation and have the water shed model. This is part of the Public Education program.

There being no further business to come before the Board, a **Motion** was made by Secretary Greg Kuntz, seconded by Chairman Roger Messmer. **Motion** carried 2-0, and the meeting was adjourned at 9:00 a.m.
