MINUTES OF THE REGULAR MEETING OF THE STORMWATER MANAGEMENT BOARD OF THE CITY OF JASPER June 9, 2025

The Stormwater Management Board of the City of Jasper, Indiana, met in regular session on June 9, 2025, in the Council Chambers of City Hall located at 610 Main Street.

CALL TO ORDER

Secretary Greg Kuntz, who presided, called the meeting to order at 8:00 a.m.

Secretary Greg Kuntz announced that a majority of the board members must be present for a quorum. One of the three members were present; therefore, there was not a quorum for the meeting.

PLEDGE OF ALLEGIANCE

Secretary Greg Kuntz led the Pledge of Allegiance.

APPROVAL OF THE MINUTES

The Board member examined the minutes of the regular meeting that was held on May 12, 2025. No motion for approval of the Minutes presented because no quorum was present.

CLAIMS

City Engineer Chad Hurm presented claims in the amounts of \$12,204.85 from May 9, 2025, through June 6, 2025. No motion for approval of the Claims presented because no quorum was present.

STORMWATER DEPARTMENT REPORTS by City Engineer Chad Hurm

Project Site Update: City Engineer Chad Hurm stated that currently stormwater is being placed on the Downtown Project between 8th-9th Street and inspections were completed. Some changes were needed to be made, and sidewalks are currently being poured.

Country Club Estates Project moved over to Emily Street with no storm sewer at this point. It's in process. Trail Project has no storm sewers work currently, only drainage pipes are being placed.

STORM WATER DEPARTMENT REPORTS by Stormwater Coordinator Chad Mundy

ERU Update: Stormwater Coordinator Chad Mundy presented to the Board a copy of the May 2025 Building Permits, with a total of six ERUs indicated on the list. No motion for approval of the ERU's presented because no quorum was present.

IDEM Monthly Report: Stormwater Coordinator Chad Mundy stated that the monthly IDEM report has been completed and filed. The report listed 7 open sites that were inspected. There were two rain events over ½" of rain and a total of 3.88" of rain for the month of May.

Site updates: Stormwater Coordinator Chad Mundy updated the Board on several construction sites in the city. He noted progress on each site.

Erosion Control Permits: Stormwater Coordinator Chad Mundy stated that there are no new permits since the last Stormwater Board meeting.

Illicit Discharge & Spills: Stormwater Coordinator Chad Mundy stated there is one illicit discharge and illicit spills to report.

• A resident on Leslie Drive poured biodegradable foam out onto the curb. Chad Mundy did log the incident and educated the resident about the situation. The resident did clean up the spill.

IDEM Update: Stormwater Coordinator Chad Mundy stated that City Engineer Chad Hurm, Engineering Technician Scott Schnell, Street Commissioner Jeff Theising and himself attended the MS4 Annual Conference.

Southwestern Indiana Stormwater Partnership: Stormwater Coordinator Chad Mundy stated that they met at the MS4 Annual Conference. Next meeting will be June 18, 2025.

Hike & Learn Project: Stormwater Coordinator Chad Mundy stated that he attended the Farmer's Market on June 7, 2025. This free event he was able to educate the public about water quality.

Public Education Plan: Stormwater Coordinator Chad Mundy stated he did present the water shed model at Jasper Middle School 8th Grade Science Classes. The students did receive a cooler, cup and candy after they completed an educational crossword puzzle.

2025 Stormwater Department Inspection Dates: Stormwater Coordinator Chad Mundy shared with the Board the dates and plans for City of Jasper Department Inspections and plans reviews.
