Ordinance No. 2025-11 – An Ordinance Approving and Authorizing a Loan Between the Gas Department and the Water Department within Jasper Municipal Utilities and Other Matters Connected Therewith This ordinance approves a loan between Gas and Water for the Skyline Subdivision Primary Project (\$580,000) and the 13<sup>th</sup> Street Water Line Replacement Project (\$713,000) and Alternative (\$279,000) at an interest rate based off the current month's investment rates but not greater than 2% for a period of five years with the first payment being due August 1, 2025 and the loan being paid off July 31, 2030.
