

INVITATION TO BID

Notice is hereby given that the Board of Public Works and Safety ("Board") of the City of Jasper, Indiana, ("City") is accepting sealed bids until the hour of 9:00 A.M. on Tuesday, November 25, 2025, at the Clerk-Treasurer's Office, Jasper City Hall, 610 Main Street, Jasper, Indiana, 47546 at which time there will be a public meeting for receiving and opening bids, for the furnishing of Materials hereinafter described for the use by the City during the contract year ending December 31, 2026. Bids will be opened publicly and read aloud at above time and place for the following items:

ITEM #1 - Crushed Stone

ITEM #2 - Bituminous Materials

ITEM #3 - Bituminous Patching Materials

ITEM #4 - Concrete and Flowable Fill

ITEM #5 - Gasoline - Regular Unleaded – All Grades and E-85

ITEM #6 - Diesel Fuel - Premium Grade-Clear- Undyed

ITEM #7 - Supply 500 gallons or more of all grades of gasoline and/or diesel fuel to various departments of the city.

ITEM #8 – Sidewalk Construction, Repair and Replacement

Bids will be received and contracts let, separately, for each line or class of materials. Bidders shall quote prices per unit on each of the referenced line or class of materials only for which the bidder desires to submit a bid.

Specifications and forms may be obtained at the Clerk-Treasurer's office located in City Hall.

Each bid must be submitted on a City's '**Bidders Form**' and must include the following:

- 1) A bid bond, certified check or cashier's check in an amount no less than 10% of the bid price
 - Place each bid in separate envelopes, designating the item number
 - If more than one item number is bid, enclose bond or check covering all bids in the envelope containing the lowest bid item number
- 2) Non-collusion Affidavit
- 3) Indiana Legal Employment Declaration: As required by I.C. 22-5-1.7 et seq., the successful bidders shall be required to enroll in and verify the work eligibility status of all newly hired employees through the E-Verify program and shall be required to sign an affidavit affirming that the contractor does not knowingly employ an unauthorized alien.
- 4) Anti-Nepotism Form
- 5) Affidavit Regarding Non-Responsibility

Forms 2 through 5 and BIDDER'S FORM are available at the City Clerk-Treasurer's office.

The Board reserves the right to reject any and all bids and waive informalities in bidding and to accept such bids as it deems to be in the best interest of the City. The Board also reserves the right to hold Bids up to 60 calendar days from the receipt of the Bid. All bids, unless otherwise specified, shall be considered a firm bid for the entire contract. All bids shall be made, and successful bidder's contracts shall be fulfilled, in accordance with the relevant provision of IC 36-1-12-3(b) and IC 5-22-7.
