• 7. Resolution 2025-5 A Resolution Approving an Interlocal Cooperative Agreement Between the City of Jasper and the City of Huntingburg for the U.S. 231 Corridor Relinquishment Study

This Resolution approves an interlocal agreement between the City of Huntingburg and the City of Jasper for a comprehensive corridor study of the transportation, land use, infrastructure, and financial impacts of the relinquishment by INDOT of US 231 and gives the Board of Public Works authority to negotiate a contract with Avenew for the study of the effects of relinquishment of US 231 within the corporate boundaries of the City of Jasper.

• • • • 8. Ordinance No. 2025-13 An Ordinance Appropriating Additional

Money for the Remainder of the Year Ending December 31, 2025

This Ordinance appropriates additional money in certain funds for the remainder of the year and reduces appropriations in other funds for the remainder of the year.

Requires PUBLIC HEARING. Notice was published in the Herald on October 11, 2025.

Requesting ONE READING ONLY Procedure.

9. Ordinance No. 2025-19 An Ordinance Affixing Salaries and Wages for the Elected Officials and the Civil City Employees for the Year 2026 This Ordinance approves proposed salary and wage adjustments for the calendar year 2026 at an increase of 3% for all full time hourly and salaried Civil City positions including the Mayor and the Clerk Treasurer and 3% for certain permanent part time and seasonal or temporary part time Civil City positions plus other Civil city organizational and salary/wage adjustments within the city.

Requesting ONE READING ONLY Procedure.

• 10. Ordinance No. 2025-20 An Ordinance Affixing Salaries and Wages for the Utility Employees for the Year 2026

This Ordinance approves proposed salary and wage adjustments for calendar year 2026 at an increase of 3% for full-time salaries and hourly Utility positions, 3% for all permanent part-time Utility positions, 3% for temporary or seasonal part-time Utility positions, plus other Utility organizational and salary/wage adjustments within the city. Requesting ONE READING ONLY Procedure.

11. Ordinance No. 2025-18 An Ordinance of the Common Council Repealing of Ordinance No. 2016-15 the Same Being Chapter 1.106 ELTF Underground Storage Tank Financial Responsibility Deductible Fund

This Ordinance repeals Ordinance No. 2016-15 in its entirety as well as all codified provisions of Chapter 1.106 and directs the Clerk Treasurer and the JMU controller to close the fund and any dedicated account or investment instrument in which funds are held. The balance shall be transferred to the City's Wastewater/Sanitary Sewer funds. *Available for FIRST READING*.

12. Ordinance No. 2025-21 An Ordinance Providing for a Uniform Code for Traffic Upon the Public Streets of the City of Jasper, Indiana (Amending Jasper Municipal Code § 9.40.030

This Ordinance amends the speed limits on County Road 490 West from a point at which it enters the corporate boundaries of the City of Jasper then south to a point that is 215 feet south of Pebble Drive to thirty-five (35) miles per hour.

Requesting FIRST READING.

13. Ordinance No. 2025-22 An Ordinance Establishing Fees for Activities of the Jasper Department of Parks and Recreation (Amending Section 1.15.020 of the Jasper Municipal Code)

This Ordinance amends various fees for facility rentals, camps, leagues, boat permits, lot and dock rental and swimming pool fees effective after passage.

• • • 14. Ordinance No. 2025-23 An Ordinance Establishing a Special Non-Reverting Capital Fund for the Department of Parks and Recreation (Amending Ordinance No. 2016-2)

This Ordinance amends Ordinance No. 2016-2 to allow revenue received by the City through its contract wit GolfNow or any other online reservation service used by patrons of that facility to be deposited in the special Golf Pro Shop non-reverting capital fund. *Available for FIRST READING*.

15. Ordinance No. 2025-24 An Ordinance Amending Section 14.20.100 of the Jasper Municipal Code to Establish a Fee for Spill Kits Used in the Abatement of Illicit Discharges

This ordinance amends Ordinance No 2023-36 to add a Spill Kit Fee of One Hundred Dollars in addition to any other administrative fees, remediation costs, fines, or penalties for illicit discharge abatement. *Available for FIRST READING*.

• • Ordinance No. 2025-14 An Ordinance Appropriating Money for the City of Jasper, Indiana for the Year 2026

This ordinance appropriates funds for the fiscal year 2026. *Available for SECOND/FINAL READING*.

• 17. Ordinance No. 2025-15 – An Ordinance Levying Taxes and Fixes the Rate of Taxation for the City of Jasper, Indiana for the Fiscal Year Ending December 31, 2026.

This ordinance shows the advertised tax rates needed to fund the 2026 budget.

Available for SECOND/FINAL READING.

18. Ordinance No. 2025-16 – An Ordinance Providing Options for the Enforcement of the Penal Provisions Contained in the Municipal Code of Jasper and for the Classification of Violations Thereof, All in Accordance with the Applicable Statutes of the State of Indiana. This ordinance revises the civil penalty amounts to better reflect the seriousness of each violation, promote compliance with Jasper Municipal Code, and ensure consistency with statutory limitations. Available for SECOND/FINAL READING.
