• 7. Ordinance No. 2025-22 An Ordinance Establishing Fees for Activities of the Jasper Department of Parks and Recreation (Amending Section 1.15.020 of the Jasper Municipal Code)

This Ordinance amends various fees for facility rentals, camps, leagues, boat permits, lot and dock rental and swimming pool fees effective after passage.

Available for SECOND/FINAL READING.

• • 8. Ordinance No. 2025-23 An Ordinance Establishing a Special Non-Reverting Capital Fund for the Department of Parks and Recreation

(Amending Ordinance No. 2016-2)

This Ordinance amends Ordinance No. 2016-2 to allow revenue received by the City through its contract wit GolfNow or any other online reservation service used by patrons of that facility to be deposited in the special Golf Pro Shop non-reverting capital fund. *Available for SECOND/FINAL READING*.

• 9. Ordinance No. 2025-24 An Ordinance Amending Section 14.20.100 of the Jasper Municipal Code to Establish a Fee for Spill Kits Used in the Abatement of Illicit Discharges

This ordinance amends Ordinance No 2023-36 to add a Spill Kit Fee of One Hundred Dollars in addition to any other administrative fees, remediation costs, fines, or penalties for illicit discharge abatement. *Available for SECOND/FINAL READING*.

• • • Ordinance No. 2025-26 An Ordinance Vacating a Portion of a Public Wright of Way

This ordinance vacates a public rights-of-way and public utility easements. Requires Public Hearing – Public Hearing noticed on 11/6/25. Requesting ONE READING ONLY PROCEDURE. Was given a favorable recommendation by the Plan Commission on 11/5/25 and USB 11/17/25.

• • • 11. Ordinance No. 2025-25 An Ordinance Establishing Rules and Regulations for the Adoption, Amendment or Repeal of Ordinances and Resolutions

(Amending Ordinance No. 2025-1)

This ordinance determines that all ordinances and resolutions shall be read by title only unless otherwise required by law or proposed by council. *Available for FIRST READING*.

• 12. Ordinance No. 2025-27 An Ordinance Amending Rates and Charges for Customers of the Jasper Municipal Electric Utility (Amending Jasper Municipal Code §11-08.060 – Green Energy Program)

This ordinance amends the Green Energy Program rate to reflect IMPA's new green power energy rate per kWh, in addition to the existing rates and charges.

Available for FIRST READING.

13. Ordinance No. 2025-28 An Ordinance Establishing User Fees and Policies for the Department of Storm Water Management, Concerning Construction Site Storm Water Runoff Control, Regulating Control of Post Construction Storm Water Runoff, Requiring Permits for the Drainage of Storm Water to the City of Jasper Drainage Structures, and Other Matters Related Thereto

(Amending Section 14.20.040 regarding Stop-Work Orders)

This Ordinance amends Jasper Municipal Code to allow the City Engineer

or Storm Water Coordinator to issue a suspension of MS4 discharge access (also known as "stop work order") when necessary. *Available for FIRST READING*.

13. Redevelopment Commission – TIF Spending Plan

This plan outlines the RDC Spending Plan for the Year 2026 based off of current obligations and historical information.

Adopted by RDC on 11/4/25.
