

**MINUTES OF THE REGULAR MEETING OF THE
STORMWATER MANAGEMENT BOARD OF THE CITY OF JASPER
September 8, 2025**

The Stormwater Management Board of the City of Jasper, Indiana, met in regular session on September 8, 2025, in the Council Chambers of City Hall located at 610 Main Street.

CALL TO ORDER

Chairman Roger Messmer, who presided, called the meeting to order at 8:00 a.m.

ROLL CALL

Also, present were Mayor Dean Vonderheide, City Engineer Chad Hurm, Stormwater Coordinator Chad Mundy, Street Commissioner Jeff Theising, and Engineering Technician Scott Schnell.

Chairman Roger Messmer announced that a majority of the board members must be present for a quorum. Two of the three members were present; therefore, there was a quorum for the meeting.

PLEDGE OF ALLEGIANCE

Chairman Roger Messmer led the Pledge of Allegiance.

APPROVAL OF THE MINUTES

The Board members examined the minutes of the regular meeting that was held on August 11, 2025. Secretary Greg Kuntz **motioned** to approve the minutes as presented. Chairman Roger Messmer seconded. **Motion** passed 2-0.

CLAIMS

City Engineer Chad Hurm presented claims in the amounts of \$10,062.87 from August 8, 2025, through September 4, 2025. Secretary Greg Kuntz made a **motion** to approve the claims as presented. Chairman Roger Messmer seconded. **Motion** passed 2-0.

STORMWATER DEPARTMENT REPORTS by City Engineer Chad Hurm

Project Site Update: City Engineer Chad Hurm stated that:

- Construction on the intersection of 9th and Main Street to be completed soon. Ragle will be sending out a claim shortly for that intersection project.
- **Lining project** with the Jasper Street Department will be completed soon.

STORM WATER DEPARTMENT REPORTS by Stormwater Coordinator Chad Mundy

ERU Update: Stormwater Coordinator Chad Mundy presented to the Board a copy of the August 2025 Building Permits, with a total of thirteen ERUs indicated on the list. Secretary Greg Kuntz made a **motion** to approve the lists as presented with thirteen total ERUs from the building permits. Chairman Roger Messmer seconded the motion. **Motion** Passed 2-0.

IDEM Monthly Report: Stormwater Coordinator Chad Mundy stated that the monthly August IDEM report has been completed and filed. The report listed 5 open sites that were inspected. There were two rain events over $\frac{1}{2}$ " of rain and a total of 2.8" of rain for the month of August.

Site updates: Stormwater Coordinator Chad Mundy updated the Board on several construction sites in the city. He noted progress on each site.

Erosion Control Permits: Stormwater Coordinator Chad Mundy stated that there are no new permits since the last Stormwater Board meeting.

Illicit Discharge & Spills: Stormwater Coordinator Chad Mundy stated there are two illicit discharge and illicit spills to report.

- Cranberries Restaurant was seen washing their fry vents in their parking lot. Mundy had a meeting with the manager and educated them the proper steps to take, and the incident will be documented.
- Tar material was spotted splattered on the pavement of Meridian Road with no known individual at fault. Incident will be documented.
- Update on the diesel fuel that spilled off a truck and onto the street. A bill was sent to Stan Wehr to cover costs for supplies to clean up the spill.

IDEM Update: Stormwater Coordinator Chad Mundy stated that his department has had frequent IDEM audits as of now the City of Jasper is not scheduled for a IDEM audit.

Southwestern Indiana Stormwater Partnership: Stormwater Coordinator Chad Mundy stated importance of training and then shared upcoming events. Next partnership meeting is on September 17, 2025 and next training session is on October 22, 2025. INAFSM conference is September 10th – Sept 12th at French Lick Resort.

SOP Construction Post Construction Plan: Stormwater Coordinator Chad Mundy stated that he is 75% completed with this plan. Working with Anna Starks of Christopher Burke to finalize these plans.

2025 Stormwater Employee Training: Stormwater Coordinator Chad Mundy stated how important training is for city employees. Mundy would like Christopher Burke to coordinate and complete this year's training courses.

INAFSM: Stormwater Coordinator Chad Mundy stated that there is an INAFSM Inspector Group which he participates in and they will have zoom meeting every other month to go over states issues and training sessions.

Jasper Group Ditch: Stormwater Coordinator Chad Mundy stated that he is working with Chad Hurm to make a plan for Jasper Group's ditch. There are a couple different options they could use, a 2 stage ditch or smaller pipe along with a geo cell ditch. The ditch has been surveyed and waiting for the results to start a plan.

There being no further business to come before the Board, a **Motion** was made by Secretary Greg Kuntz, seconded by Chairman Roger Messmer. **Motion** carried 2-0, and the meeting was adjourned at 8:30 a.m.
