

**MINUTES OF THE REGULAR MEETING OF THE  
STORMWATER MANAGEMENT BOARD OF THE CITY OF JASPER  
October 13, 2025**

The Stormwater Management Board of the City of Jasper, Indiana, met in regular session on October 13, 2025, in the Council Chambers of City Hall located at 610 Main Street.

**CALL TO ORDER**

Chairman Roger Messmer, who presided, called the meeting to order at 8:00 a.m.

**ROLL CALL**

Also, present were Mayor Dean Vonderheide, City Engineer Chad Hurm, Stormwater Coordinator Chad Mundy, Street Commissioner Jeff Theising, City Attorney Renee Kabrick, Legal Administrative Assistant Jane Chambers, and Engineering Technician Scott Schnell.

Chairman Roger Messmer announced that a majority of the board members must be present for a quorum. Two of the three members were present; therefore, there was a quorum for the meeting.

**PLEDGE OF ALLEGIANCE**

Chairman Roger Messmer led the Pledge of Allegiance.

**CLAIMS**

City Engineer Chad Hurm presented claims in the amounts of \$161,787.93 from September 5, 2025, through October 9, 2025. Vice Chairman Brad Albright made a **motion** to approve the claims as presented. Chairman Roger Messmer seconded. **Motion** passed 2-0.

**STORMWATER DEPARTMENT REPORTS by City Engineer Chad Hurm**

**Project Site Update:**

- City Engineer Chad Hurm stated the construction on Main Street and Multi-use Trail Project are finished.
- The Country Club Estates Project storm sewer is being laid on 20<sup>th</sup> Street.
- 50/50 Projects are taking place pouring new sidewalks.
- This fall possible lining projects are starting.
- The application for another Community Crossing Grant are in motion.

**STORM WATER DEPARTMENT REPORTS by Stormwater Coordinator Chad Mundy**

**Stormwater Board Dates:** Stormwater Coordinator Chad Mundy stated the dates will be the same for next year board meetings and a possible new alternate board member for substitution.

**Resolution for Spill Kit:** Stormwater Coordinator Chad Mundy stated a need for a supporting Ordinance to be placed to recover the expense of Spill Kits. Vice Chairman Brad Albright made a

**motion** to approve the resolution for Spill Kit for \$100.00 as presented. Chairman Roger Messmer seconded the motion. **Motion** Passed 2-0.

**ERU Update:** Stormwater Coordinator Chad Mundy presented to the Board a copy of the September 2025 Building Permits, with a total of five ERUs indicated on the list. Vice Chairman Brad Albright made a **motion** to approve the lists as presented with five total ERUs from the building permits. Chairman Roger Messmer seconded the motion. **Motion** Passed 2-0.

**IDEM Monthly Report:** Stormwater Coordinator Chad Mundy stated that the monthly September IDEM report has been completed and filed. The report listed 4 open sites that were inspected. There were two rain events over ½” of rain and a total of 2.17” of rain for the month of September.

**Site Updates:** Stormwater Coordinator Chad Mundy updated the Board on several construction sites in the city. He noted progress on each site.

**Erosion Control Permits:** Stormwater Coordinator Chad Mundy stated that there are no new permits since the last Stormwater Board meeting.

**Illicit Discharge & Spills:** Stormwater Coordinator Chad Mundy stated there were several illicit discharge and illicit spills to report.

- On 3<sup>rd</sup> Street, a container dropped off a truck, JPD and Street Department placed down absorbent and cleaned up the spill.
- On Sixth Street, an individual washed off their tools after drywall work in an inlet near their house. The inlet drained to Sixth Street.
- Custom Concrete company poured mortar mix into the storm drain. This was called in by Street Department.
- Fleck Construction poured concrete washout on the ground without using a concrete washout.
- Mehringer Brother’s mortar mix was poured into GAB’s landscaping.
- After celebrating Kids’ Day someone poured lemonade and lemons down storm drain at Jasper City Hall’s parking lot.
- On Main Street, McAlister Rentals had a hydraulic hose busted, absorbents were applied to the spill.
- On Plymouth and Dodge Street, illicit material on the street, so Messmer Mechanical placed silk fencing to help from wash out.
- A hydraulic hose came off a Kimball truck and spilled onto Cherry Street. Absorbents placed down by Kimball and clean up.
- Schroeder Complex, a taco truck poured their cleaning water down a stormwater drain.

**IDEM Update:** Stormwater Coordinator Chad Mundy stated that there will most likely be an MS4 audit next year. With the permit cycle ending at the end of next year, the City of Jasper will need to apply for a new permit from IDEM. Chad Mundy stated he will be working on the paper work for the new permit.

**Southwestern Indiana Stormwater Partnership:** Stormwater Coordinator Chad Mundy stated IDDE training is coming up and a possibility of being hosted in Jasper.

**SOP Construction Post Construction Plan:** Stormwater Coordinator Chad Mundy stated that Christopher Burke Engineering has completed the Construction & Post Construction SOP. Chad

Mundy stated he will be reviewing the document. He will also continue working with Anna Starks & Christopher Burke Engineering on this project.


**2025 Stormwater Employee Training:** Stormwater Coordinator Chad Mundy stated how beneficial training is for city employees and requested that Anna Starks & Christopher Burke will be presenting this year's training.

**Public Education and Outreach:** Stormwater Coordinator Chad Mundy stated utility bill stuffer will be going out with the utility bill to inform the public what is and not permitted to go down the storm drain.

**Rotary Club Meeting:** Stormwater Coordinator Chad Mundy stated he will be the guest speaker at the next Rotary Club Meeting. This is part of the Public Education program.

There being no further business to come before the Board, a **Motion** was made by Vice Chairman Brad Albright, seconded by Chairman Roger Messmer. **Motion** carried 2-0, and the meeting was adjourned at 9:00 a.m.
