

**MINUTES OF THE REGULAR MEETING OF THE
STORMWATER MANAGEMENT BOARD OF THE CITY OF JASPER
November 10, 2025**

The Stormwater Management Board of the City of Jasper, Indiana, met in regular session on November 10, 2025, in the Council Chambers of City Hall located at 610 Main Street.

CALL TO ORDER

Chairman Roger Messmer, who presided, called the meeting to order at 8:00 a.m.

ROLL CALL

Also, present were Mayor Dean Vonderheide, City Engineer Chad Hurm, Stormwater Coordinator Chad Mundy, Legal Administrative Assistant Jane Chambers, and Engineering Technician Scott Schnell.

Chairman Roger Messmer announced that a majority of the board members must be present for a quorum. All three members were present; therefore, there was a quorum for the meeting.

PLEDGE OF ALLEGIANCE

Chairman Roger Messmer led the Pledge of Allegiance.

APPROVAL OF THE MINUTES

The Board members examined the minutes of the regular meeting that was held on October 13, 2025. Secretary Greg Kuntz **motioned** to approve the minutes as presented. Vice Chairman Brady Albright seconded. **Motion** passed 3-0.

CLAIMS

City Engineer Chad Hurm presented claims in the amounts of \$20,985.65 from October 10, 2025, through November 6, 2025. Secretary Greg Kuntz made a **motion** to approve the change order of \$4,040.00 as presented for the lining project on Schuetter Road. Vice Chairman Brady Albright seconded. **Motion** passed 3-0.

Secretary Greg Kuntz made a **motion** to approve the claims as presented. Vice Chairman Brady Albright seconded. **Motion** passed 3-0.

STORMWATER DEPARTMENT REPORTS by City Engineer Chad Hurm

Project Site Update: City Engineer Chad Hurm stated some potential lining projects at the Lions Club Park.

STORM WATER DEPARTMENT REPORTS by Stormwater Coordinator Chad Mundy

LSI Program: Stormwater Coordinator Chad Mundy stated the significance of this partnership with the program and presented to the board their cause of farming measures and analyze data. Brenda Sermersheim, Kaylee Jacob & Andrew Frey shared with the board their request for

donations and explained their mission for quality water and promote good soil health. Employment declaration contract and land stewardship incentive agreement was signed by the board. Secretary Greg Kuntz made a **motion** to donate \$1,000 as presented. Vice Chairman Brady Albright seconded. **Motion** passed 3-0.

ERU Update: Stormwater Coordinator Chad Mundy presented to the Board a copy of the October 2025 Building Permits, with a total of nine ERUs indicated on the list. Secretary Greg Kuntz made a **motion** to approve the lists as presented with nine total ERUs from the building permits. Vice Chairman Brad Albright seconded the motion. **Motion** Passed 3-0.

IDEM Monthly Report: Stormwater Coordinator Chad Mundy stated that the monthly October IDEM report has been completed and filed. The report listed 4 open sites that were inspected. There were two rain events over ½” of rain and a total of 2.79” of rain for the month of October.

Site Updates: Stormwater Coordinator Chad Mundy updated the Board on several construction sites in the city. He noted progress on each site.

Erosion Control Permits: Stormwater Coordinator Chad Mundy stated that there are no new permits since the last Stormwater Board meeting. Chad Mundy stated he is review a new plan for the Jasper High School addition.

Illicit Discharge & Spills: Stormwater Coordinator Chad Mundy stated there is one illicit discharge and illicit spills to report.

- Jasper Police Department was called with a complaint of a resident changing oil in the apartment’s parking lot on Kirkwood Drive. Chad Mundy checked on any improper dumping and educated the individual about proper disposal of fluids from the car.

IDEM Update: Stormwater Coordinator Chad Mundy stated that he will start on the annual report soon, informed the board that a possible IDEM audit next year, and will be working with Staci Goodwin regarding the new tiered permit system.

Southwestern Indiana Stormwater Partnership: Stormwater Coordinator Chad Mundy stated the next IDDE meeting is 11/18/2025 in Chandler, Indiana.

SOP Construction Post Construction Plan: Stormwater Coordinator Chad Mundy stated he is working with Christopher Birk Engineering to finalize the document. Ordinance codes are being changed and updated. City Engineer Chad Hurm did add more details to the new code ordinance updates. Secretary Greg Kuntz made a **motion** to approve stormwater management board resolution 2025-2 as presented. Vice Chairman Brady Albright seconded. **Motion** passed 3-0.

Public Education and Outreach: Stormwater Coordinator Chad Mundy stated the six minimal control measures for public education and did share this with the Rotary Club Meeting at Jasper City Hall.

City Engineer Chad Hurm added at the end of the meeting clarification regarding the Inliner Solution contract. The quantities previously of 140 lineal ft, but the corrected is 178 ft which is an additional 38 ft of lining that had to be done. A correction of \$7,600, instead of the \$4,040 as previously stated. The change order is \$7,600. New contract amount is \$35,600...ament the request City Engineer Chad Hurm presented claims in the amounts of \$56,585.65 Secretary Greg Kuntz made a **motion** to approve the claims as presented. Vice Chairman Brady Albright seconded. **Motion** passed 2-0.


