- • • 11. **Ordinance No. 2026-3 An Ordinance Establishing Uniform Authority for the Sale of Alcoholic Beverages by the City at City Facilities**
This Ordinance consolidates authority for the City to sell alcoholic beverages at City operated facilities into a single chapter of the Municipal code, allows continued sale of beer and wine but adds sale of certain prepackaged alcoholic beverages, requires board approval and ATC permitting.
